

STATEMENTS OF COMMITMENT TO REDUCE REGULATORY BURDEN AND FOSTER A PRO-ENTERPRISE ENVIRONMENT

- 1. Deputy Prime Minister and Minister for Trade and Industry Mr Gan Kim Yong, who chairs the Inter-Ministerial Committee (IMC) on Pro-Enterprise Rules Review, announced three **Statements of Commitment** at the MTI Committee of Supply debate 2025.
- 2. To guide collective efforts across Whole-of-Government in reducing compliance burden, the IMC on Pro-Enterprise Rules Review has set three Statements of Commitment to address businesses' feedback on Government regulations, in consultation with regulatory agencies:
 - i. First, all agencies should publish service standards for the processing of business regulatory applications. Where feasible, service standards should be within 30 working days. The Annex includes a list of business regulatory applications with service standards within 30 working days. Agencies will review and expand this list over time.
 - ii. Second, all agencies should increase the validity period of business licences to a minimum of three years, with an aim towards five years where possible. Where it is not feasible to have a minimum three-year validity period (e.g. due to public health, safety or security reasons, or where licensees have poor track records), agencies will explain why. Agencies can also continue issuing provisional licences to new businesses, before awarding a longer validity period during renewal.
 - iii. Third, the Government will continue to streamline regulatory processes to minimise sequential regulatory approvals and duplicative information requests from multiple agencies.
- 3. The Statements of Commitment will be complemented by three pillars of work to enhance the business support ecosystem to navigate Government regulations, namely:
 - i. The Small and Medium-Sized Enterprises (SME) Pro-Enterprise Office, which will be fully operational from 26 March 2025, will be the key coordination unit within the Government, working with the Pro-Enterprise Panel and regulatory agencies to aggregate business feedback and improve regulations at the systems level.
 - ii. **SME Centres**, operated by trade associations and chambers, to help SMEs navigate regulations with the support of SME Pro-Enterprise Office.

- iii. **Digital platforms** to streamline licensing and regulatory transactions and serve businesses at scale, such as GoBusiness² and CORENET X³.
- 4. Mr Gan Kim Yong said, "The business operating environment has become more complex over the years. To better understand concerns from our businesses and support them in moving fast to seize economic opportunities, the Government has engaged our businesses extensively in the past year. The Statements of Commitment, developed in consultation with regulatory agencies, will assure businesses of the Government's resolve to improve regulatory efficiency and reduce compliance burden, to enable our businesses to remain competitive in a more pro-enterprise environment."
- 5. The IMC was formed in April 2024 to review cross-cutting regulatory issues and reduce compliance burden for businesses, especially SMEs. The Committee comprising Deputy Prime Minister and Minister for Trade and Industry Mr Gan Kim Yong, Minister for Home Affairs and Law Mr K. Shanmugam, Minister for Transport and Second Minister for Finance Mr Chee Hong Tat, Minister for Manpower and Second Minister for Trade and Industry Dr Tan See Leng, Minister for National Development Mr Desmond Lee and Senior Minister of State for Trade and Industry & Culture, Community and Youth Ms Low Yen Ling has since engaged more than 140 business leaders across 14 sectors for feedback on improving regulatory agility and strengthening Singapore's regulatory framework. Regulatory agencies are reviewing all feedback and will provide updates in due course.
