## GOVERNMENT INDUSTRIAL LAND SALES PROGRAMME FOR SECOND HALF OF 2006

The Ministry of Trade and Industry today announced the Government Industrial Land Sales Programme for the second half of 2006. Three sites will be placed on the Confirmed List, and another three sites on the Reserve List.

## **Confirmed List**

- 2. The Government launched five sites in the Confirmed List in Dec 2005 for the first half of 2006 Industrial GLS. Tender for three of the sites, Tuas South Ave 2/3, Bedok North Ave 4 and Woodlands Industrial Parks E2/E9, were closed in April, May and June 2006 respectively. All 3 tenders were subsequently awarded.
- 3. In view of the demand for industrial land, MTI will place three industrial land sites totalling 4.1 ha on the Confirmed List for the second half of 2006. These are:
