GOVERNMENT INDUSTRIAL LAND SALES PROGRAMME FOR FIRST HALF OF 2007

The Ministry of Trade and Industry today announced the Government Industrial Land Sales Programme for the first half of 2007. There will be two sites in the Confirmed List and four sites in the Reserve List.

2. Under the Industrial GLS programme for the second half of 2006, the Government launched and awarded three sites in the Confirmed List¹. Two sites from the Reserve List² were also launched for sale in December 2006, with the tenders closing in the next few days.

Confirmed List

3. For the first half of 2007, MTI will place two industrial land sites totalling 3.3 ha on the Confirmed List, to meet the continued demand for industrial land. These are:
