MR CHIANG CHIE FOO RE-APPOINTED AS CHAIRMAN OF ENERGY MARKET AUTHORITY

The Minister for Trade and Industry has reappointed Mr Chiang Chie Foo as Chairman of the Energy Market Authority (EMA). The Minister has also appointed Ms Chan Lai Fung as the Board's Deputy Chairman. Both appointments took effect from 1 April 2007.

2. Mr Chiang has been Chairman of EMA since its formation on 1 April 2001. His capable leadership and vision has helped EMA establish a sound regulatory framework for the liberalization of the electricity and gas industry. In the past six years of his chairmanship, EMA had reached several milestones in opening up the energy utilities sector for fair competition and concurrently enhancing power supply security and efficiency.

3. Mr Chiang is also the Permanent Secretary, Ministry of Defence and concurrently Permanent Secretary, Prime Minister's Office.

Management University. Ms Chan's extensive experience will prove useful to the Board.
