

LAUNCH OF FIRST HALF 2010 INDUSTRIAL GOVERNMENT LAND SALES (GLS) PROGRAMME

The Ministry of Trade and Industry (MTI) today launched its Industrial Government Land Sales programme for first half of 2010. In view of the improved economic conditions, and to continue to meet demand for industrial land, MTI will reinstate the Confirmed List and replenish the supply of sites on the Reserve List. There will be two sites in the Confirmed List and eight sites in the Reserve List, with a total site area of 21.85 ha.

Reinstatement of Confirmed List

2. For the first half of 2010, MTI will place two sites on the Confirmed List. The two sites are as follows:

3. In 2009, three Reserve List sites at Kaki Bukit Road 2, Woodlands Industrial Park E5/Woodlands Avenue 4 and Pioneer Road North/Soon Lee Drive were sold. For the first half of 2010, MTI will introduce one new site at Pioneer Road North/Soon Lee Road (Parcel 2) on the Reserve List. In addition, seven sites from the second half of 2009 Reserve List will be carried forward to first half of 2010. The details of the eight sites in the Reserve List for the first half of 2010 are as follows:
