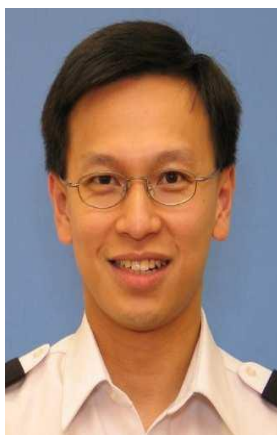
New SPRING Board Members
