

As the Commissioner, Mr Lee has pushed for IRAS to excel in managing both tax compliance and customer service. Prior to this, Mr Lee had served as Permanent Secretary in the Ministries of Labour, Community Development and Health.

6. Mr Ngiam is currently the Deputy Secretary (Industry) in the Ministry of Trade and Industry, where he oversees policies to develop Singapore's economy. He was formerly the Special Assistant to Emeritus Senior Minister in the Prime Minister's Office. Prior to that, he was the Director of Community Relations and Engagement at the Ministry of Community Development, Youth and Sports (MCYS) where he promoted community bonding and racial and religious harmony, and helped to develop volunteerism and philanthropy. He was also concurrently the Director of the Social Sector Planning Unit. Mr Ngiam has also served in the Ministry of Home Affairs and the Ministry of Education.
