Mr Aedit Bin Abdullah, S.C. (义帝阿都拉) Chief Prosecutor (Criminal Justice Division) Attorney-General's Chambers

As the Chief Prosecutor of the Criminal Justice Division, the Attorney-General's Chambers (AGC), Mr Aedit supervises, on behalf of the Public Prosecutor, the prosecution of capital cases, drug and specialist crimes, the monitoring of prosecutions by other agencies, as well as the provision of advice on criminal matters to government agencies and the development of general criminal policy. He is also Chairman of the Crime Cluster Management Committee, which coordinates the work of the three Crime Divisions within the AGC.



Mr Aedit has a sterling career in the Legal Service and rich experience in different government departments. He had previously served as a Justice's Law Clerk, a Deputy Senior State Counsel in the Civil Division, and a District Judge. He was seconded to the Monetary Authority of Singapore on two occasions. He has also taught at the Faculty of Law, National University of Singapore. Mr Aedit was appointed Senior Counsel in 2012.

Mr Aedit has also served on various committees and working groups for the Singapore Academy of Law. He has a First Class Honours, LLB from the National University of Singapore and a First Class for his Bachelor of Civil Law degree at the University of Oxford. In addition, he read public management at the Lee Kuan Yew School of Public Policy and was awarded the Lee Kuan Yew Prize for Best Student.
