

NEW CHAIRMAN AND BOARD MEMBERS APPOINTED AT INTERNATIONAL ENTERPRISE SINGAPORE

Mr Seah Moon Ming, currently Deputy Chairman of International Enterprise (IE) Singapore, will be appointed as Chairman with effect from 1 January 2014. He takes over from Mr Sunny Verghese, who will step down on 31 December 2013.

2 In addition, two new members will be appointed to the board of IE Singapore, and four existing board members will be re-appointed. These appointments will also take effect from 1 January 2014.

Mr Sunny Verghese(森尼・魏吉思)

3 Mr Verghese, Group Managing Director and Chief Executive Officer of Olam International Limited, was appointed Chairman of IE Singapore on 22 April 2008. Under his leadership, IE Singapore developed a comprehensive suite of programmes and schemes to help grow Singapore companies into globally competitive companies. These initiatives included the Market Readiness Assistance, a broad-based



assistance designed for companies new to internationalisation; and the Global Company Partnership, a strategic, customised assistance for those with existing overseas presence looking to deepen their overseas engagement.

4 During Mr Verghese's tenure as the Chairman, IE Singapore established new strategic relationships through the opening of five new Overseas Centres in Accra, Ghana; Istanbul, Turkey; Johannesburg, South Africa; Yangon, Myanmar; and Wuhan, Central China. Partnerships with international organisations were also developed to support Singapore companies' entry into emerging markets, including with the World Bank and Asian Development Bank.

5 Mr Verghese is also an active champion of free and open trade, and a strong advocate for strengthening Singapore's position as a global leading trade hub. IE Singapore, in collaboration with other agencies, has also driven the initiative to remove Goods and Services Tax from investment-grade precious metals and inputs to refineries, putting Singapore in a good position to become the leading precious metals trading hub in Asia.

6 Mr Seah Moon Ming, Group Chief Executive Officer of Pavilion Energy Pte Ltd, has been a member of the IE Singapore board since 1 January 2008 and was appointed Deputy Chairman for the last two years.

7 Mr Seah's extensive background and knowledge will be useful in guiding IE Singapore towards achieving its



goals as well as charting new directions. His insights in the LNG sector are invaluable to the Board's deliberations on achieving IE Singapore's strategic goals for international trading. With his deep market knowledge of China, Mr Seah provides invaluable insights, guidance and personal contacts to IE Singapore, helping Singapore deepen its business engagement with China. He is also the Vice Chairman of China Business Group under the Singapore Business Federation.

8 In addition, Mr Seah's vast connections in the electronics and ICT sectors and exposure to markets like the US, Europe and China will continue to benefit IE Singapore as it looks to develop the Latin American and Middle Eastern markets for companies, particularly in infocomm technology-related sectors.
