STREAMLINING CUSTOMS PROCEDURES FOR LAND INTERMODAL TRANSHIPMENTS

Singapore, 20 December 2024 – As part of the Ministry of Trade and Industry (MTI) and Singapore Customs' (Customs) ongoing efforts to work with businesses to address key challenges including regulations, MTI and Customs have collaborated to facilitate smoother cross-border movement of goods. Specifically, Customs is introducing a new procedure for land intermodal transhipments in response to industry feedback and as part of ongoing efforts to streamline trade processes.

- 2 Currently, goods transhipped through Singapore's land checkpoints at Woodlands and Tuas are treated as imports for re-export. This requires traders to apply for two separate permits: one for importation and another for exportation. To simplify this process, from 1 January 2025, traders will need to apply for only a single transhipment permit for land intermodal transhipments.
- This new procedure is expected to benefit businesses significantly:

- Cost Savings: Businesses may save up to S\$40 per transhipment, potentially resulting in annual industry-wide savings of up to S\$2 million.
- Time Efficiency: The time required to prepare customs permits will be reduced by 50%.
- This initiative supports Malaysia and Singapore's efforts under the Johor-Singapore Special Economic Zone to strengthen economic cooperation and improve movement of goods between Singapore and Johor. MTI and Customs will continue to engage with industry stakeholders to improve trade processes between Singapore and Malaysia. This is in line with the broader intent where MTI, Customs and other relevant agencies work closely with businesses to understand and address their concerns on regulatory issues, under the ambit of the Inter-Ministerial Committee on Pro-Enterprise Rules Review established in April 2024.
